Cibolo Valley Baptist Church met for the regular scheduled business meeting, February 12, 2017.

The meeting was facilitated by Pastor Jeff Roman.

Minutes of the December meeting were presented. A motion was made by Jim Gardner to accept the minutes as presented. Joe Thele seconded the motion and the motion carried.

Gloria Hill presented the treasurer's report, explained overages, and answered questions. Larry Cleary made a motion to accept the report as presented. The motion was seconded by Jim Fowler and the motion carried.

REPORTS:

Other attached reports were to be reviewed by members at their leisure. The reports included the written Prayer Ministry, Sunday School, Children's Ministry, and Church Clerk Report.

OLD BUSINESS:

Property and Space – Gregg Wilkinson gave a Property and Space update. He stated the next Workday is scheduled for April 1st at 9:00 A.M. There are several things needing work and all available help is needed.

NEW BUSINESS:

New Mission Statement – Joe Thele presented the new mission statement for CVBC. After some discussion the statement, "Love God, Love Others, Reach the World" was unanimously accepted.

WOW – A discussion was held on whether to modify Worship on Wednesday or stay with the current program. After some discussion, a motion was made by Joe Thele to table this item until the next business meeting. Bobbi Thele seconded the motion and the motion carried,

The change will allow the administrator to be a committee member of Property and Space, but not the chairman. Gloria made a motion to accept the change. Gregg Wilkinson seconded the motion and the motion carried.

Mission Conference – Pastor Jeff stated there will be a mission conference in Dallas on May 19th and 20th. He asked who would like to attend. Those wanting to attend are: Bobbi Thele, Eve Johnson, John McDougal, Jeff Roman, Maritza Roman, and C. J. Williams. More information is to follow later.

Pastor Salary – Administrator, Jim Gardner, took over the meeting as Pastor Jeff excused himself from this discussion. Jim and Stewardship presented a proposal to increase the Pastor’s salary by \$10,800 a year. It was pointed out Pastor is being paid well below the average salary for a pastor in a church the size of CVBC. After some discussion, Joe Thele made a motion to increase the salary by the proposed amount. C. J. Williams seconded the motion and the motion unanimously carried.

Next Business Meeting – The next business meeting will be April 23, 2017 due to Easter being April 16th.
