Cibolo Valley Baptist Church met for the regular scheduled business meeting, April 23, 2017.

Minutes of the February meeting were presented. A motion was made by Joe Thele to accept the minutes as presented. Ed Salzwedel seconded the motion and the motion carried.

Gloria Hill presented the treasurer's report, explained overages, and answered questions. Ed Salzwedel made a motion to accept the report as presented. The motion was seconded by Jim Fowler and the motion carried.

OLD BUSINESS:

Property and Space – Gregg Wilkinson gave a Property and Space update. He stated the current sign is not being repaired, cameras are being installed, we will be getting a defibrillator, and the old cement ramp is being removed after some discussion.

Mission Trips – Bobbie Thele reported there are nine (9) signed up for the Oklahoma trip and more volunteers are needed. **The volunteers have ordered T-shirts to wear on the July 10th to 14th trip.** The group will be doing Vacation Bible School and Outreach while in Oklahoma.

The Del Rio trip will be June 3rd to 9th. During this trip, the group will be helping with a Vacation Bible School sports camp and outreach. There are 8 signed up for the Del Rio trip at this time. There will be a May 7th meeting for both trips.

Mission Conference – Pastor Jeff stated those signed up for the Dallas Conference needs to pay \$50 for single person or \$75 for couples by May 1st.

Prayer Chain – June Noggle requested more people to sign up for the phone prayer chain and sent the signup sheet around the members present,

NEW BUSINESS:

New Members – Gloria Hill presented new members to the church body to vote on, with the condition they attend the new members class being held April 30th. Ed Salzwedel seconded the motion and the motion carried.

Personnel Motion – Kelly Eiland presented a recommendation and motion from the Personnel Committee to make Secretary, Kristi Castro, full time. Kristi's hours would be increased to 25 hours per week from 20 hours. Kristi will also receive two weeks of vacation time, The motion carried with one member dissenting.

Deacon Candidate – Joe Thele presented Jon Gabriel Wilson to the church body to be ordained as a Deacon. Jon Gabriel gave a brief statement and answered questions. A secret ballot was taken and Jon was unanimously accepted for ordination.

Classical Conversations – A Christ centered group, Classical Conversations, wants to use the church buildings once a week from 8 AM to 3 PM. Natasha Weave gave an overview of their activities as they are associated with a similar group. After discussion and answering questions, Ed Salzwedel made a motion to allow the group to use the church. Maritza Roman seconded the motion and the motion carried.

Endorsement – A discussion was held on endorsing Pastor Jeff to attend classes for his doctorate. Gloria Hill made a motion the church endorse Pastor Jeff to attend the necessary classes. C. J. Williams seconded the motion and the motion carried.

Tabernacle Trailer – The issue of the trailer with the tabernacle being parked on the church property was deferred to Property and Space committee.

Workday – The next workday will be July 8th.

Next Business Meeting – The next business meeting will be June 25, 2017 due to Father's Day being on June 18th.
