OLD BUSINESS:

They will come out with an appraiser to appraise the property value in order for the city to pay the church for the property. The project may start sometime time in 2018. Jim also reported he is talking to another insurance company about getting a quote for church insurance to see if we can save any money.

Mission Trips – C. J. Williams reported on the planned mission trips. Bobbi Thele reported there are 29 to 30 people going to Oklahoma. An advance trip was made to see what is needed. Some of the men will be going up a week ahead of time to do demolition. The trip is planned for June 19th to 24th.

Robbie East reported the Del Rio mission trip has 10 going to hold a sports camp June 4th to 9th. There will be a meeting on April 23rd. Housing is being provided by the Del Rio church members.

NEW BUSINESS:
